

2020 Annual Members Meeting and Elections of the Board of Directors

On **Sunday, September 13, 2020 at 3:00pm**, the German Society will hold its **2020 Annual Meeting and Elections for Directors** at 611 Spring Garden Street, Philadelphia, PA 19123. Members must be in good standing to be eligible to vote, i.e. current on dues no later than end of business on **Friday, September 11, 2020**. Members wishing to vote must be present at the meeting; there is no provision for absentee ballots or proxy voting under the Society's By-laws.

Please be reminded that members at the Associate level (\$30/year) are not eligible to vote in our elections; if you an Associate member and would like to vote, please contact the Society's office to upgrade your membership to a higher level. There are five openings for Directors on the Board in the class of 2023. There are six candidates competing for these positions. There are also three Officer positions up for election: Treasurer, Assistant Treasurer, and VP of Finance.

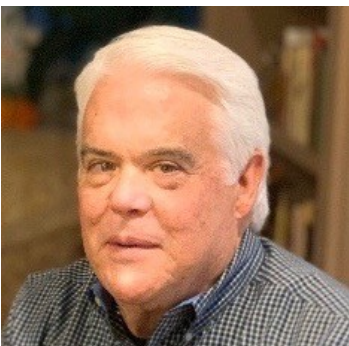
