## President's Message

In her New Year's Day address, Chancellor Angela Merkel pointed out that Germany has long been a country of new ideas and inventions. But—unless they are implemented, they are of no benefit.

The same principle applies to the German Society. The leadership team, in the short year since being elected to office, has succeeded in turning around the organization, because it delivered on the strategy of reducing cost and increasing revenue. In both areas we were able to rely on your unrelenting support and the admirable volunteer efforts of various stalwart members.

Our Annual Fund Drive brought in a record \$43,500 thanks to your tremendous generosity. (A supplementary list of Donor Acknowledgments is shown on page 3). Ernie Weiler and I are very grateful that you heeded our call for added contributions. Please rest assured these will be used wisely!

Several essential capital improvement projects have been identified, for which we are now seeking grant money from various institutions. A sprinkler system must be installed to protect our historic buildings and the precious library collection. Also, the large single-pane windows in our auditorium, which date back to late Nineteenth Century, urgently need to be replaced—for economic as well as safety reasons. These two projects are estimated to cost a little over \$300,000 of which we will have to raise a portion on our own as proof of our commitment to the cause.

## **Mural Project**

Philadelphia is well-known for its Mural Arts Program (MAP). It began in 1984 as a part of the Anti-Graffiti Network, a city-wide initiative to eradicate destructive graffiti and address neighborhood blight. To date, MAP has painted approximately 2,400 murals throughout the city.

In an effort to improve the appearance of our historic buildings, we started last fall to paint our doors, windows, etc. However, there is a large, unsightly blank wall adjacent to our site facing the entrance of our administrative building that detracts from our beautification endeavors. Hence, we thought it appropriate to develop plans for a mural project reflecting our cultural part in Philadelphia's history.



Earlier this year, we were encouraged by Jane Golden, MAP's Executive Director, to proceed with this project by filing an official application. This was done by the indicated deadline of March 15. The total cost of a full-sized mural amounts to \$10/15,000 of which the applicant has to carry only a portion, since MAP's work is publicly subsidized. We anticipate celebrating the unveiling of this mural as a community event in 2007.

## Scholarship Awards

On April 8, the Scholarship Committee of the German Society and the Women's Auxiliary awarded six scholarships to university students. These awards were based on academic record and interviews with the applicants.

The scholarships, ranging from \$500 -\$2,500, are to be used toward tuition in the upcoming academic year. These funds will be directed to the following German majors at colleges in the Greater Delaware Valley:

ARTICLE X Meetings of Members of the Society ....

10.5-Quorum. A] Fifteen (15) Twenty-five (25) members in good standing shall constitute a quorum at any and all meetings of the members.

B] All action except election of officers and directors shall be by vote of the majority of those members present and entitled to vote at such meeting.

C] Election of officers and directors shall be by a plurality of members present and entitled to vote at such meeting.

#### ARTICLE XX Disposal of Funds and Securities Assets of the Society ....

20.1-None of the funds of the Society, or the contents of any safe deposit box registered in the name of the Society, may be withdrawn or removed, nor any of its securities transferred except on the signature of any two of the following: any of the Stated Officers and/or the Executive Director.

20.2 A two-thirds vote of the Board of Directors at a stated board meeting and a two-thirds vote of the membership at a regular stated meeting of the membership shall be required to mortgage real estate of the Society. [This wording reflects a provision that has been in our Articles of Incorporation since 1870.]

20.3 In the event of the dissolution of the Society, the Board of Directors or in the absence thereof, governing staff shall, after paying or making provision for the payment of all the liabilities of the said Society, dispose of all the assets of the said Society in such manner, or to such organization(s) organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as (an) exempt organization(s) under § 501 (c) (3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), as the said Board of Directors or governing staff shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Society is then located, exclusively for such purposes as said Court shall determine, which are organized and operated exclusively for such purposes. [This wording reflects a provision added to our Articles of Incorporation in 2006 in order to preserve our eligibility for exemption from PA sales tax.]

#### ARTICLE XXII Amendments....

C] The notice for such meeting at which final action is to be taken by the members shall contain a copy of the proposed amendments, or a summary thereof together with a statement that a complete copy of the proposed amendments is on file at the office of the Society for inspection by members, and such copy shall be so on file,

D] Actions taken by the Executive Committee shall be reported to the Board of Directors <u>at a subsequent expeditiously and no later than the next Board meeting.</u>

E] The Executive Committee shall appoint a sitting Stated Officer other than the President to serve at its pleasure as Executive Vice President in addition to his or her other office.

F] The Executive Vice President, if any, shall act in the President's stead for any and all of the purposes enumerated herein, in the event of the incapacity or death of the President, or upon delegation by the President. [Former 7.2- B]

#### ARTICLE IV Nominations and Elections....

- 4.1....B] Names in nomination shall be solicited from the general membership no later than forty-nine (49) days preceding the annual meeting. At a regular meeting of the Board of Directors at least fifty (50) fourteen (14) days preceding the annual meeting of the Society, or at any adjournment thereof, the chair of the Nominating Committee shall certify to the meeting the offices to be filled at the next election. Nominations for such elective offices shall be made at this meeting by the Nominating Committee....
- 4.2-Elections....C] In the event of a contest for any office, the Secretary shall prepare and distribute a ballot to the members of the Society present in person at the meeting and the President shall appoint a Judge of Election to tabulate the votes. The said ballot may reflect the contested offices only.

ARTICLE V Meetings of the Board of Directors....

5.4-Adjourned Meetings....C] No Reasonable notice of the any adjourned Board meetings need shall be given to the absent Board members.

#### ARTICLE VII Duties of Officers

- 7.1-President....D] The President shall, by and with the approval of the Board of Directors <u>and in consultation with the appropriate Vice President</u>, appoint the chairs of all committees, of which the President shall be an ex-officio member.
- 7.2-Vice President. A] Each Vice President shall have such powers and perform such duties as may be delegated by the President. B] [content moved to 3.5 –F]
- C] The remaining Vice Presidents shall then advance in accordance with their respective seniority as a member of the Board....
- 7.4-Treasurer. The Treasurer shall assure that accurate accounts of the receipts and disbursements of the Society are maintained; shall cause financial reports to be provided to the Board as requested, but not less than quarterly, and to the members as requested, but not less than quarterly, and to the members as requested, but not less than annually; shall oversee the preparation of the annual budget in cooperation with the Finance Committee; and shall perform such other duties as may be delegated by the President.

#### Article VIII Solicitor

8.1-A] The Solicitor shall be designated by the Board and shall be an experienced and duly accredited attorney-at-law <u>practicing entitled to practice</u> in Pennsylvania.

#### ARTICLE IX Membership in the Society....

9.2-Election to Membership. A] Applications for membership shall be submitted by the Membership Committee at any regular or special meeting of the Board of Directors. The President shall, from time to time, direct the Secretary to notify all persons with Board of

Directors voting rights of the names of those who have applied for membership, and of the member sponsoring each such applicant.

- B] Election to membership shall be by vote of the Board. If none of the persons with Board voting rights directs an objection in writing to the Secretary within fourteen (14) days of notification, each such applicant shall be deemed admitted to membership. Membership cards and welcome letters shall then be issued to those admitted to membership.
- C] If a timely objection to admitting any applicant for membership is received by the Secretary, the question of admitting or denying admission to the said applicant to membership shall be placed on the agenda of the next regularly scheduled Board meeting.

## **Proposed By-Law Amendments**

In any healthy organization, the by-laws are always a work in progress. A number of items needing renovation have cropped up in ours. A committee comprised of Doris Simon, Frank Genieser, and me has recommended changes, approved by the Board, to be voted on at the annual meeting. Here is a summary of their substance:

Re-electing officers every two years, to coincide with the president's term. It is hoped that the shortened commitment will make it easier for prospective officers to see their way clear to serve.

Making the term limits for officers one step less strict.

Reducing the term limits for Directors, to conform to the existing Strategic Plan.

Establishing a mechanism for removing Directors, since there can occasionally be circumstances when a Director becomes a serious liability or impediment to the Society.

Appropriately redefining the powers and *modus operandi* of the Executive Committee.

Improving nomination, election and by-laws revision procedures.

Improving the job descriptions for the treasurer and the solicitor.

Expediting the process of admitting new members.

Reflecting distinctive provisions of our Articles of Incorporation in our by-laws.

Please take some time to review these proposed changes.

#### ARTICLE II Stated Officers ....

2.1- A] The Stated Officers shall be a President, one or more Vice Presidents, a Secretary, a Treasurer, and such other offices as the Board of Directors may designate. The Stated Officers shall be elected by the members of the Society as provided herein. The President Each Stated Officer shall be limited to serve three (3) consecutive two-year terms in any one office, and until the President's such officer's successor has been duly elected or appointed.

B] There shall be a limit of (1) one four-year term for each other officer effective Section 2.1- A shall take effect with the elections for the year 2003 2007.

#### ARTICLE III Board of Directors....

- 3-2-.... B] There shall be a limit of four (4) three (3) successive terms for each director effective with the annual meeting elections for the year 2001 2007. Any such director may stand for election after an interval of one year following the expiration of the fourth third
- C] Each Board member shall serve on at least one Committee, shall use best efforts to secure funding for the Society, and shall use best efforts to act in the best interest of the Society.
- DI The Board may, by a simple majority, remove from Board membership any member whom the Board finds; {1} continually and recurrently puts forth little or no effort to advance the purposes of Section 3.3- C; or {2} acts in a manner or makes a declaration contrary to the said purposes; or {3} is absent from three (3) Board meetings within a period of twelve (12) months in office. The procedure for such removal shall be the same as that specified in Section 13.2- C.
- 3.5-Executive Committee. A] The Executive Committee shall consist of the officers of the Corporation. Members of the Board of Directors may attend any meeting of the Executive Committee.
- B] The Executive Committee shall have and may exercise, between the meetings of the Board of Directors, all the powers and authority of the Board to take necessary, exigent operational decisions including personnel decisions.
- C] The President or any two members of the Executive Committee may call meetings at any time, giving the purpose of the meeting
- three (3) days' written notice to the Board of Directors of the date, place and time of the meeting. The President and three other offi-

Now, life has returned to the Society, and it would be a pleasure for me to assist in program development, cultural planning, including "fun events", and -last but not least—library activities.


